



ARTICLES OF INCORPORATION OF THE CLUB HOMEOWNERS ASSOCIATION

T

The name of the corporation is THE CLUB HOMEOWNERS ASSOCIATION, referred to as ("Association").

II

This corporation is a non-profit mutual benefit corporation organized under the non-profit mutual benefit corporation law. The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such law. Additional purposes of this corporation are:

To form a residential real estate management association and to provide for the acquisition, construction, management, maintenance, and care of real and personal property held by the association, or commonly held by the members of the association, or located in the development and owned by members of the association, or located in the development and owned by members of the Association, and otherwise to act and be operated as a "Homeowners Association" as defined in Section 528 of the Internal Revenue Code of 1954, as amended.

III

The name of the corporation's initial agent for service of process is Harry C. Crowell, 521 North Mountain Avenue, Suite A, Upland, California, 91786.

IV

The affairs of this association shall be managed by a board of five (5) directors who need not be members of the association. The number of directors may be changed only by amendment to these Articles of Incorporation.
